The following points were discussed during the meeting and the minutes were recorded as below:

The Principal has formally welcomed the Chairman and all members of the Governing Council and presented the detailed agenda. The Vision and Mission of the Institution was presented in the meeting.

- 1. Department's Vision & Mission and PEO Formation Information to members.
- 2. The members insisted to ensure the publishing and dissemination of Vision & Mission of Institute and Department, and PEO of the programs to all stakeholders.
- 3. (a) Members analyzed the quality of the online classes being conducted.
 - (b) Principal explained the innovative teaching methodologies adopted and various pedagogies for making online classes more engaging.
 - (b) Principal explained about the need for OBE awareness program for all the faculty members.
 - (c) Principal explained the process of conducting and monitoring the online classes.
 - (d) Chairman appreciated the faculty members for their continued efforts in conducting online classes
 - (e) Members suggested providing wireless headsets to all the faculty members for conducting the online classes.
 - (f) Chairman approved budget for procuring the head sets for all the faculty members.
 - (g) Members suggested to go for ISO certification to ensure quality education.
 - (h) Chairman directed Vice Principal to explore the possibility of applying ISO certification. RESOLVED that the college Governing Council reviewed and approved the IQAC initiatives including usage of pedagogy and OBE awareness programs for improving quality of teaching learning.
- 4. (a) Vice Principal brought the issue of maintaining the lab equipment which are not in use for a long duration. He suggested forming a team of faculty and non-teaching staff to take up the service and maintenance of machines during lock down period.
 - (b) Chairman advised to take help of campus engineering team for the service & maintenance work.
- 5. (a) Principal suggested Dr.C.Suresh Kumar to set up Centre of Excellence to promote the students skill set in the emerging fields.
 - (b) Chairman directed Vice Principal to explore the possibility of creating CoE's in KITE.
- 4. (a) Members suggested to bring in a few UG/PG new courses as per AICTE policy.
- (b) After discussion, chairman directed Principal and Director to discuss on this and decide upon the name of the courses.
- (c) Finally, it is decided to start a management course in PG level (MBA) and to start a UG course in B.Tech. CSBS and to increase in intake in B.Tech. AI & DS in the upcoming academic year

2021-22. As the norms doesn't permit to go for a new course, it is decided to reduce the intake of BE-Mechanical Engineering.

- (d) Chairman approved to apply for the above courses in the next academic year.
- 5. RESOLVED that the college Governing Council reviewed and approved the listed initiatives recommended by IQAC on various academic and administrative activities.
 - a. Reviewed the activities of Placement and Training Cell
 - b. Reviewed the Curricular and extracurricular activities
 - c. Reviewed the Academic & Administrative audit.
- 6. RESOLVED that the college Governing Council reviewed the Results of Anna University, Chennai Examinations held during NOV/DEC 2019.
- 7. RESOLVED that the college Governing Council ratified the appointments of the Teaching, Non-Teaching and Administrative staff members.
